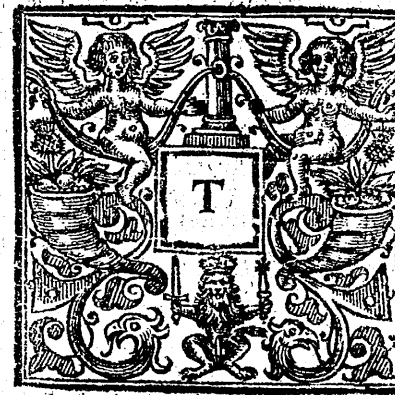


**ACTS**  
**DONE AND PAST IN THE**  
**Third Session of the second Triennial Parlia-**  
 ment: Holden at *Edinburgh*, and beginning the 23. of  
*May* 1649. and ending the 7. day of *August*  
 in the year afore said.

**ACT I.**

*Act nominating the Earl of Lowdown Lord Chan-*  
*celler, President of this Session of*  
*Parliament.*

23 *May*, 1649.



THE ESTATES of Parlia-  
 ment now presently convened in  
 this third session of the second  
 Triennial Parliament, Taking to  
 their consideration the Fiftie Act  
 of the Kings Majesties second Par-  
 liament, Holden at *Edinburgh*, in  
*Anno* 1641. Intituled, *Act a-*  
*ment the Election of the President of*  
*Parliament*, Together with the forty  
 two Act of the last Session of the  
 First Triennial Parliament, of the  
 Date, At *Edinburgh* the Twentie  
 seventh of *March* 1647. Intituled,  
*Act ament the Election of a President*  
*of Parliament, for ilk Session of Par-*  
*liament* explaining the former act, concerning the time of endurance  
 of the President of Parliament; And according hereunto *John Earle of*  
*Lowdown*

Lowdown High Chancellor of Scotland, President of the last Parliament, Having Ministred the oath of Parliament to the whole Members of Parliament present, and represented to them the two Acts of Parliament abovementioned, which were read in audience of Parliament; The saids Estates of Parliament after voycing, did elect and choyse the said Iohn Earle of Lowdown High Chancellor of Scotland To be president of this session of Parliament, And to precede thereinto as President of Parliament during this session of Parliament, And while the taking of the oath of Parliament, and election of another President in the next Session of Parliament, Conform to the foresaid fourtie two Act of Parliament, of the 27. of March; the year 1647.

ACT II.

Act Continuing the Committees of war in the severall Shires untill they be of new elected.

23. May, 1649.

THE Estates of Parliament now presenly convened in this third session of the second Triennall Parliament, Taking to their consideration That the necessitated and urgent affaires of the Countrie requires a constant Committee of War to reside in every Shire, to be assisting for performance of such things as shall be thought fit and requisit by the Parliament or Committee of Estates, for the weal of the respective Shires; Therefore, they have prorogate and continued the whole severall Commissions granted to the Committees of warr, To the same persons as they were established in the last Session of this Triennal Parliament, in the whole respective Shires: And Gives, Grants and Renews to them the same full power as was contained in the said former Commissions, Ordaining them to sit and meet at their ordinary times, or oftener as occasion requires, And to doe every thing according to the tenor of the forsaid Commissions till the same be renewed.

ACT III.

Act continuing the maintenance for the moneth of June, 1649.

29. May, 1649.

THE Estates of Parliament Having considered the dangerous posture of affaires in this Kingdom, both in respect of intestine and forraign Enemies; And with all perceiving that the designs and attempts of the evill affected are still to involve the Kingdom in new troubles, And being obliged in discharge of the trust committed to them To take care of the safety of the Kingdom, as they resolve for themselves to use all Lawfull wayes and peaceable meanes to prevent these dangers, So they have thought fit to prorogate and continue the monethly Maintenance as the same was imposed upon the Kingdom for the moneths of March, Aprill last, and May instant, For the space of a moneth after the said moneth of May instant, viz. for the moneth of June 1649. And therefore statutes and ordaines that ilk Shyre and Burgh within this Kingdom are and shall be lyable and obliged in payment of the particular summes of money, as they were obliged in the former Act of Maintenance made upon the Seventh of March last 1649. And that betwixt and the day of the said moneth of June; And ordains the same to be payed to Sir James Stewart of Kirkseild Knight Provest of Edinburgh, Thesaurer of the Armie and collector of the said maintenance and his deputies and subcollectors, and that the sums to be payed by the severall Shires and Burghes be the like sums as was payed for one moneth of the saids former three moneths; For the better inbringing & collecting whereof, The saids Estates of Parliament allowes to the said collector of the maintenance and Clerk of Collection appoynted by him, the same allowance they had formerlie, and siclike to all collector deputies and Clerks one or more in each Shire To be nominat by the Committee of Warr thereof, betwixt and the day of June next, with such fees as the Committees of Shires shall allow, not exceeding the former allowance; which collector deputies shall find sufficient caution to the collector generall, wherein if the Committees of War shall faile, The generall collector after the day foresaid to appoint his own subcollectors in these Shires who shall happen to faile to nominate and find surety; And Ordains the saids subcollectors to be comptable, and Letters, charges and all executions to follow upon this act for payment of the said moneths maintenance, with the same wayes for putting in execution against deficient; And the debtors to have the same retention from creditors, And the same persons to have exemption from payment of the said moneths maintenance as is contained in the said Act of the Seventh of March last; And discharges any

any suspension to be granted without consignment in manner mentioned in the said act of the Seventh of March last; And Ordains all heritors within Burgh, pendicles and liberties thereof To contribute with them for payment of the maintenance, as is contained in the act of the 27. of February last; And Ordaines the same course to be taken a- nent the payment of maintenance for Lands & Teinds as they ly local- lie in Shires and Burghs: And Declares and grants the same priviled- ges to the Lords of Session, And grants the same power ament the publick moneyes of Loan, Taxt, bygone maintenance, tenth and twenty pennies, borrowed moneyes restand unpayed or uncompted for: And gives the same power to the respective Committees of War of Shyres to take Tryall thereof, and to make report thereof to the Parliament: And Discharges any heretors from exacting any part of their mainte- nance from their tenants, except upon hearing of both parties before the Committees of Warr of the severall Shyres, As is mentioned and contained ament these whole particulars in the said former Act of the Seventh of March 1649.

ACT IIII.

Act anent the sitting of the Lords of Session constant- ly in tyme coming during their ordinary tyme.

ult: May 1649.

THE Estates of Parliament now presently Convened in this third session of the second Triennall Parlia- ment, Taking to their Consideration, that albeit by former Proclamations, It was intimate at the mar- cat Crose of Edinburgh, that the Lords of council and Session were to sit down the first day of June now in- stant for administration of Justice to the Leidges; yet hearing that the troubles of the country, and the meeting of the Parliament, have possessed many with feares of the not sitting of Session; And least by misinformation the Leidges should suffer, They have thought fit of new again to intimate to the Leidges, that as the saids Lords are now sitting down for administration of justice, So God willing they are to continue therein till the last of July next to come, And that the Estates of Parliament do intend and resolve with Gods assistance for the tyme to come (notwithstanding of the meetings of Parliament) and als far as is possible (notwithstanding of the troubles of the countrie) To cause the saids Lords keep constantly the ordinary moneths of Session for administration of justice: & therefore Ordaines all our sovereign Lords Leidges who have busines before the saids lords, To attend the said session, and this to be intimate to them by found of Trumpet at the Mercat Crose of Edinburgh.

ACT V.

Act anent the assurance given by the Lieutenant Generall, To those who did rise in the late Rebel- lion in the North.

7. June 1649.

THE Estates of Parliament Having seen & considered the assurance given by Lieutenant Generall Leslie, To the Lord Ogilvie, Lewis Gordoun son to the sometime Marques of Huntlie, Thomas Mackenzie of Pluscar- dine, and to John Middelton of Fittercairne, the Te- nour whereof followes: KNOW AL MEN By thir presents, That I Lieutenant Generall David Leslie, Having power, warrant and authority granted unto me by the Committee of Estates of this Kingdom, for giving of the assurance underwritten, Do hereby in their name become obliged and give assurance to everie one who shall subscribe the band herewith presented, that their lives and Estates, fortunes and liberties shall nor be called in question to them by the Estates of this Kingdom, or their Committees, For any thing done by them or any of them In relation to, and for prosecution of the late unlawfull Engagement, Or in relation to, the present troubles and com- motions in the north, raised since the said late unlawfull Engagement; They and everie one of them observing, keeping and fulfilling the whole tenour, heads and clauses of the security for keeping the peace of the Kingdom, Granted and subscribed by them at the making here- of; Which assurance of mine to the persons under subscribers, I ob- blige my self To get Ratified and approven of, At the next ensuing Parliament: In witness whereof I have subscribed thir presents with my hand At the first day of June 1649 years, Before thir witnesses, DOE HEREBY Give assu- rance To them, and such others as at the making of the said assurance by Leivtenant Generall Leslie did subscribe the band for keeping the peace of the Kingdome; And shall deliver in their bands betwixt and the first day of October next 1649. That their lives, Estates, fortunes and liberties shall nor be called in question by the Estates of this Kingdom, or by their Committees for any thing done by them or any of them In relation to, and for prosecution of the late unlawfull Engagement, Or in relation to the present troubles and commotions in the North, raised since the said late unlawfull Engagement, They and every one of them observing, keeping & fulfilling the whole tenor, heads and clauses of the security for keeping the peace of the Kingdome: Granted & sub- scribed at the giving of the forsaide assurance by the Leivtenant Gene- rall Lesly; This being always declared to be without any allowance

to

to them of the titles which they usurpe to themselves in the writing & subscribing of the said Band: As also without any prejudice to the protection granted by the Leivtenant Generall at that time to the tenants and servants of the persons abovenamed.

ACT VI.

Act anent the dayes of comprisings, and services of Aires, when the same shall happen to fall upon dayes of publick humiliation or thanksgiving.

12. June 1649.



THE Estates of Parliament Taking to consideration the prejudice that many of the Leidges has sustained and now sustaines By denouncing of lands to be apprifed at their instance; and publishing of Briefs respective for serving of them Aires to certain peremptoric days & places for deducing of their comprisings, and serving of the saids Briefes, which days has sundry times fallen out, and may hereafter fall out To be days set apart at that time and place for publick Humiliation or Thanksgiving, which ought not to be interrupted but solemnly observed, whereby the parties having interest wil be frustrate of their former diligence, and put to new paynes and charges; THE SAIDS ESTATES of Parliament for remedie hereof; Statutes and Ordaines, and hereby finds and declares, That when any of the dayes to the which denunciations be used for comprising, or Briefes proclaimed for serving of Aires, falls out to be either upon a day appointed for publick Humiliation, Fasting and Praying or publick Thanksgiving, at that place where their comprisings or services are to be, That it shall be sufficient and lawfull to the parties interested, And to the Judges inquest and other members of court To use the saids apprifings & service of the Brives respective foresaid upon the morrow thereafter, not being the Lords day, which if it be, upon the day following the same, which the Estates declares to be als valid as if the same had been done upon the peremptoric day, to the which the lands were denounced to be apprifed, or the Brives proclaimed to be served.

ACT VII.

Act anent execution of poynding to follow upon Sheriffs and other inferior Judges their decreets.

12. June 1649.



THE Estates of Parliament now presently Conveened in this third Session of this second Triennal Parliament, Taking to their consideration that albeit by Act of Parliament of the day of years, Letters of Horning are Ordained to be direct by deliverance of the Lords of Session upon Sheriffs, Commissars and other inferior judicatories their decreets upon the simple charge therein mentioned; Yet the Act bears no warrant for Letters of poynding to be granted by the delyverance foresaid upon these decreets, whereby the parties interest obtainers of the decreets, are oft-times prejudged of their payment, when these parties against whom these decreets are obtained doe sit or remove out of the Shyre or jurisdiction of the judge before whom the saids decreets are given; T herefore the saids Estates Ratifies the Act of Parliament, abovementioned In the whole heads & points thereof, And for remedie of the prejudice foresaid, Ordaines Letters of poynding to be direct, by deliverance of the Lords of Session at the instance of the parties interest upon the saids Sheriffs, Commissars and other inferior Iud ges their decreets contained in the foresaid Act; Sielike and in the same manner as Letters of Horning are appoynted by the said Act to passe upon the same decreets. That thereby the parties may have reall execution as well as personall upon their decreets foresaid.

ACT VIII.

Act of Approbation of the proceedings of the Commissioners who went to his Majesty.

14. June 1649.



THE Estates of Parliament having received from John Earle of Cassis, Alexander Brody of that ilk, Master George Winrame of Libbertoun, and Alexander Frafray Bailly of Aberdene their Commissioners sent to the Kings Majestie, The report of all their proceedings with the King, and read the papers delivered therewith to this Parliament, And being satisfied with their integritie, faithfullnesse and diligence, In contributing their utmost endeavours

for prosecuting their instructions, and for obtaining satisfaction to the desires of this Kingdom, Do therefore unanimoſlie and heartily acknowledge their faithfulneſſe and diligence, and approve their proceedings, And render to them the heartie thanks of this Kingdom for the ſame.

ACT IX.

Act anent giving in of Quarterings.

14 June 1649.

THE Eſtates of Parliament has Ordaind and Ordains That the whole Shires within this Kingdom ſhall give in, and inſtruct their Quarterings ſince the moneth of November laſt, at the Particular Diets following, viz. Theſe on this ſide of Tay, betwixt and the Firſt day of July next to come, And theſe upon the North ſide of Tay, betwixt and the fifteen of July next, With certification that theſe who ſhall not give in and inſtruct their Quarterings, betwixt and the reſpective diets foreſaids, ſhall have no allowance thereof in their Maintenance.

ACT X.

Act in favours of the Town of Edinburgh, anent the Stipends of ſix Miniſters out of the Houſe Mails.

19. June 1649.

THE Eſtates of Parliament, Having taken into conſideration the Petition of the Lord Proveſt, Bailies, and Counſels of Edinburgh, in name of the Miniſters and whole Inhabitants thereof, deſiring that the annuity of five Merks upon every hundred Merks of Mail within the ſaid Town impoſed in the preceding Seſſion of Parliament, for making up the ſum of nineteen thouſand Merks yearly for the Maintenance of ſix Miniſters, might be augmented, and a greater quota impoſed for making up that ſum according to the Declaration and Proviſion in the Act of Parliament made thereanent. In reſpect that after exact ſurvey of the whole Mails, the annuity of five upon every hundred, will not make up the ſaid ſum of nineteen thouſand Merks; And the Eſtates having conſidered their former Act of Parliament made for that yearly impoſition towards the maintenance of ſix Miniſters, and the

the Declaration and proviſion therein containd; And being very willing that the good town be well furniſhed with a ſufficient number of able and well qualified Miniſters, Do therefore (with the augmentation of the annuities after ſpecified, Ratifie, Approve and confirm the ſaid Act of Parliament, whereof the tenor follows.

At Edinburgh the ſecond day of March, the year of God, 1649. years. THE ESTATES OF PARLIAMENT now preſently convened in this ſecond Seſſion of the ſecond Triennall Parliament, By vertue of an Act of the Committee of Eſtates, who had power and Authority from the laſt Parliament (or convening the Parliament, Having conſidered the Petition of the Town of Edinburgh for approving and ratifying the Act of the Committee of Eſtates for a yearly impoſition upon the Houſe Mails and others for the Maintenance of ſix Miniſters, Together with the Report of the Committee of Bills thereanent: And being very ſenſible of the conſtant affection of the good Town of Edinburgh to Religion, and their eminent and exemplary zeal and deſire for providing and eſtabliſhing a ſufficient number of pious, able and well qualified Miniſters for their ſeverall Kirks; And taking alſo to their ſerious conſideration the vaſt charges they have been at in building of their Kirks and other publick Works, in advancing great ſums of money for the uſe of the publick towards the Maintenance of the Cauſe, and the promoting the Reformation, and the great loſſes they have ſuſtained ſince theſe great troubles and diſtractions; And being deſirous to encourage and enable them towards the maintaining and providing of a ſufficient number of able and well qualified Miniſters; Therefore, The ſaids Eſtates of Parliament, after ſerious conſideration of the premisses, And of the ſaid Petition of the good Town and Report made thereanent, Do Ratifie and Approve the Act of the Councell of the ſaid good Town of Edinburgh, with the advice and concurrence of their Neighbours upon the twenty day of October laſt by-paſt, concerning their Reſolutions to have twelve Miniſters conſtantly within the ſaid Burgh: As alſo do, Ratifie and Approve the ſaid Act of the late Committee of Eſtates of the twenty eighth day of December laſt, for yearly Impoſition of the ſum of nineteen thouſand Merks upon the Houſe Mails within the ſaid Burgh, To be a conſtant Proviſion for ſix of the twelve Miniſters of the ſaid Burgh, with the alterations and additions following: And the Eſtates of Parliament conſidering, That the providing and maintaining of the ſaid ſix Miniſters doth concern the Worſhip of God, and tend to the propagating and maintaining thereof in the chief City of this Kingdom, from which none that are partakers of ſo great a benefit will in conſcience withdraw or exeeme themſelves without great guiltineſſe before God; Therefore the ſaid Eſtates of Parliament, Do hereby Statute and Ordaine, that the yearly Stipend of ſix Miniſters be impoſed and laid upon the whole Rents and Mails of all the dwelling Houſes, Chambers, Booths, Cellers, and all other Houſes high and low paying Mail within the ſaid Town, Whilk

Imposition shall be paid by the Inhabitants and Possessors, And that without any exemption or exception of any House of whatsover holding or nature they be of, or of any person or persons of whatsover degree, quality or place they be of, upon any priviledge or pretence whatsover. And that the said Imposition may be certain and effectuall, It is Ordained, that upon every hundred Merks of Mail throughout the whole Town, the annuities of five Merks be imposed upon the whole Rents and Mails foresaid, That thereby the sum of nineteen thousand Merks may be made up yearly, to be a constant provision to six Ministers within the said Burgh, That every one of the saids six Ministers may have yearly, the sum of two thousand, seven hundred Merks for his Stipend, and four hundred Merks for his House Mail, and the four hundred Merks remaining to be allowed for the waste house Mails, and for the Collection of the said Imposition; The payment of which Imposition and annuities shall be Quarterlie each three moneths by advance, The first Quarters payment beginning at Martimas last by-past for the first Quarter, and the next Quarter being the first of February last, for the moneths of February, March and Aprill and the third quarter the first of May, for the moneths of May, June and July, And the last quarter the first of August for the Moneths of August, September and October, And so forth every year therefore quarterly each three Moneths. And that the Mailes and rents of all the houses, chambers; booths, and others afore said may be truly known, there shall be an exact survey thereof made and taken upon the oathes of the Inhabitants, and thereafter the proportion of five of every hundred imposed thereupon: And in case after exact triall upon oath by the surveyer in manner afore said, It shall be found that the imposition of five upon the hundred will not make up the said whole sum of nineteen thousand Merks, That upon report to the Parliament of what shall be wanting and inlacking, The Estates of Parliament will take to consideration what further quota shall be imposed for making up the said whole sum of nineteen thousand merkes for the constant and yearly provision of the said six Ministers. And also it is hereby Ordained That the said imposition shall alwayes be Collected by the Deacons of the Kirk, to be delivered to the Treasurer of the Kirk lessions, And is not to come in the hands of the Town Councell, nor to be applied to any other use nor is abovementioned. It is alwayes declared, that the foresaid imposition is to be laid upon the Inhabitants, Tenents and possessors without exception or exemption of any upon what Priviledge or pretence whatsover, And the said Imposition shall no wayes affect the ground, right or propertie of the houses tenements booths and others afore said, But that the proportionating and division of the foresaid sum to be payed by the inhabitants according to their mailes is onlie to be the rule and square for taxing the inhabitants for payment thereof, at the rates of the mailes payed by them and not to affect the ground as is afore said, The tenants, inhabitants and possessors, alwayes being subject in payment thereof, and

lyable

liable to personall and reall execution for the same. And seeing by the foresaid Annuities and imposition, the said Town of Edinburgh will be the more enabled to entertain twelve Ministers, It is hereby Ordained that they use all diligence for getting their Kirks provided with twelve Ministers, and for keeping alwayes that number full for the good and Instruction of the whole Inhabitants thereof; And when any of the number of the six Ministers provided by the foresaid Imposition shall vaik, the Stipend or Stipends of any of these six vakand shall be disposed upon *ad pios usus*, conform to the Act of Parliament, by the Kirk Sessions of the said Town with advise of the Committee aftermentioned appointed for deciding of Questions and differences. And because, It is not intended that any prejudice or preperative should be hereupon inferred, to the Priviledges and Liberties of the Colledge of Justice, or that any Member thereof should be unequally burdened, Therefore for preserving the Lords of secret Councell and Session, and the hail Members of the said Colledge of Justice, free from any prejudice to themselves or their Priviledges, It is Ordained, that the said annuity and imposition shall be laid upon all the Inhabitants, Tennents and Possessors of the Houses, Chambers, Boothes, and others afore said within the said Burgh, after exact survey by four sworn men in every Paroch, who shall survey and value the House Mails afore said, whereof three shall be Citizens, to be chosen and sworn by the Town Councell, and the fourth shall be nominate chosen and sworn by the Colledge of Justice or such as they shall appoint; And if the Colledge of Justice refuse or delay, being required by the Magistrates of Edinburgh as follows, viz. The President of Session and Dean of Facultie, to be required in time of Session, and any of them to be required in time of vacancie, to the effect foresaid upon six dayes, In that case the Magistrates and Councell of Edinburgh to have power after the requisition and expiring of the six dayes, to nominate, choose and swear such of the Colledge of Justice as they shall think fit, for surveying and valuing of the said House Mails: And if the Members of the Colledge of Justice, shall either not accept, or not concur in the said Employment being required, Then, and in either of those cases, the remanent of those persons chosen and sworn by the Town Councell, shall have power to go on in the said Employment, and act by themselves without the Members of the Colledge of Justice, not accepting nor concurring as said is. And if any question or debate shall happen to arise betwixt the said Collectors or any of the Members of the Colledge of Justice, concerning the valuing, exacting or up-lifting of the proportions imposed, or concerning the payment thereof, The Estates of Parliament Think it necessary that there be Committee appointed for deciding of Questions, And therefore Do hereby Appoint Sir John Hope of Craighall Knight, one of the Ordinary Lords of Session, Sir William Scot of Clerkington, one of the Clerks of Session, John Dickson of Hartie, and Mr. David Heriot Advocate for the Colledge of Justice; The

four

four Bailies of *Edinburgh* present and to come for the said Burgh, Or any five of them, two alwayes being Members of the Colledge of Iustice, and the Provest of *Edinburgh* present and to come supernumerary, to be a Committee for the effect aforesaid, Authorizing them and the *Quorum* aforesaid, with their full power to judge, decerne and determine all questions and differences aforesaid summarly, and to do all things necessary for that effect, without any interruption whatsover; Upon whose sentence execution shall follow without any interruption by suspension or other trouble: And as any of the places of these four appointed for the Colledge of Iustice shall vaik by not acceptation, decease or otherways, That the same be filled by the Colledge of Iustice, The President and Dean of Facultie in time of Session and either of them in time of vacancy being required for that effect: And in case the Colledge of Iustice shall not fill the places within six dayes after the said Requisition, the said vacant places shall be filled by the remanent Members of the foresaid Committee. And it is hereby Declared that for removing all Questions and differences, the exaction of all by-gone dues, by vertue of any former Acts of Councell, Session or Parliament, is hereby discharged to such of the Members of the Colledge of Iustice or others as do consent and give ready obedience to this present Act and make no obstruction thereunto at any time hereafter. AND THE ESTATES Having now found by the value of the whole House Mails truly & faithfully taken up diverse surveyes of sworn men, and now last by an exact surveye of the Elders and Deacons of the Sessions, with the advise of the Dean of Facultie and others Members of the Colledge of Iustice, that the annuity of five on the hundred will not make up the said sum of nineteen thousand Merks, Do Iudge it necessary towards the Maintenance of six Ministers, that the *quota* of the said Annuity be augmented one Merk more upon every hundred: And therefore do hereby Decern and Ordain, that an Annuitie of six Merks, be imposed upon every hundred Merks of the whole Mails and Rents of all the Houses, Chambers, Boothes, Cellers, and other Houses high and low, with the pertinent within the said Burgh, That the beforementioned sum of nineteen thousand Merks may be collected yearly for the Maintenance of six Ministers by the Deacons of the Kirk for the time being, in the manner before expressed, The first quarters payment thereof, beginning at the Terme of *Martinmas* last, for the Moneths of *November*, *December*, and *January*, the second Quarters payment at the first of *February* for the moneths of *February*, *March* and *April*, The third Quarter at the first of *May* last for *May*, *June* and *July*; And the last Quarters payment being upon the first of *August* next for the moneths of *August*, *September* and *October*, And so forth quarterly thereafter in all time coming in manner aforesaid. Requiring and Commanding the Deacons of the Kirk, To collect presently and gather the foresaid Annuitie of six of every hundred of the saids Mails and Rents for the three Quarters by-gone and quarterlie in all time coming, and to deliver the samen to the

Treasurer

Treasurer of the Kirk Sessions in manner abovementioned, And that the Magistrates of the said Burgh see this whole Act and Ordinance obeyed, performed and put to due execution according to the tenor thereof, Authorizing them with full power to do every thing necessary for that Effect, and The Estates also Ordain Letters of Horning and all other executorials necessary to be direct upon this Act in form as effeirs

ACT XI.

*Act for purging the Armie.*

21 June 1649.



THE Estates of Parliament considering the manifold evils both of Sin & punishment wherewith this Land has been afflicted, By reason of the Malignant Insolences and profanity of many in our Armies, And calling to mind that they have lately made a solemn confession & acknowledgement unto God thereof as one of the publick Sins of the Land, And that they have Engaged themselves for purging of judicatories and Armies, and intrusting and employing none but such as are of known good affection, and to the effect that none be suffered to bide in the Army who are of a profane, Malignant & Scandalous carriage; Having therefore according to their vows, and for removing and preventing all dangers or inconveniences that may fall out thereby, and for remedying and relieving the exorbitant burthens & oppressions of the country because of such mens insolences, Thought necessary to grant power and Commission to some well affected persons in severall Shires for visiting the Troops and Companies Quartered therein, and for ordering and directing the cashiering or otherways punishing of them as they after tryal shal find their miscarriage to deserve, And for that effect, The Estates of Parliament, grants Commission, warrant and power to

To visit the Troops and companies lying within the Shire of \_\_\_\_\_ and receive all complaints against them, to take all manner of tryall of their carriage by information or examination of the country people with whom they have been quartered, or other honest persons of the Shire, or Officers or Souldiers in these troopes either upon their oaths or otherwise as they shal think fit, And to give up to the chief Officer upon the place the list of such officers & souldiers as they shal find guilty of any of the faults contained in the instructions given to them by this present Parliament, That the said officer fourth with secure their horses and armes, & remove them out of the army, or punish them otherways as they shal deserve. And in case the saids Commissioners shal upon pregnant presumption think fit before tryal, that any officer or Souldier be secured untill they be tryed, That the chief officer upon the place, upon the desire of the saids Commissioners, shal accordingly secure the saids persons with their horses and Armes.

Articles



Articles for purging the Army, first concerning Officers.

- I. That if their be any officers in the army that served under *James Graham*, the late Marquesse of *Huntly* or their adherents against this Kingdom and cause, that these be cashiered and put out of the army.
- II. That no officer that served in the late Engagement against *England* shall be employed as Officer in the Army, or be permitted as a common souldier, or ride with a troop or company in the Army, but shall be cashiered and put out of the Army, unlesse he have been admitted by consent of the Parliament or Committee of Estates, and Generall Assembly or their Commission.
- III. That any officer who after tryall shall be found guilty of Malignant and disaffected speeches, as Railing and enveying against the Cause and Covenant, or against the Ministry, or against the present Civill Government, and such as are of a profane carriage, or are guilty of oppression, be cashiered and put out of the Army.
- IIII. That any officer who after tryall shall be found to have refused sufficient Souldiers rightly qualified, and hath taken mony for them, & interverted the same either in whole or part to his own private use, and Levied Malignant, disaffected or profane and Scandalous men in their rooms to compleat his number, That the officer that shall be found thus guilty be cashiered & imprisoned till he make restitution of the mony to the Commissioners for the use of the publick.
- V. That all Officers that levied mony for souldiers and did not compleat their number, shall restore the double to the Commissioners for the use of the publick, and be further punished as the general persons shall think fit.

Secondly, Concerning souldiers.

- I. That all Souldiers that served under *James Graham*, the late Marques of *Huntly* or their adherents against this Kingdom and cause, be cashiered and put out of the Army.
- II. That all Souldiers that want sufficient Testimonials, or are found to be guilty of railing, unlesse they be of known & approven integrity, within a convenient time to be allowed by the Commissioners for that purpose, be cashiered and put out of the Army, and their horses and Armes taken from them.
- III. That all souldiers, albeit such as have testimonials, as are found to be guilty of railing or reviling against the Cause and Covenant, or against the Ministry, or against the present civill government, And all such as are Blasphemers and mockers of Piety, or despisers of the Worship of God, or profaners of the Lords day, or oppressors of the people, or drunkards, or plunderers, or unclean persons be cashiered and put out of the Army, and their horse and Armes taken from them.
- IIII. That no person that shall maintain any error or practice contrary to the Doctrine, Worship and Discipline of this Kirk, or against the Civill

civill government by King and Parliament according to the Covenant and Declarations of this Kingdom, shall be permitted in the Army to serve as office nor Souldier but shall be removed and cashiered.

- V. That the places of such officers as shall be cashiered and removed out of the Army, being under the degere of ane captain be filled for this time by the Colonel of that Regiment with the advise & consent of the Commissioners of the respective shires where the sament are for the time appointed for purging the Army. And that the supernumeraries, women and pedees be purged out of the Army.
  - VI. That no officer receive into a troop or Regiment any of these that are purged out of the Army under the pain of cashiering, And recommends to the saids Commissioners for purging the army and the officers of the army, to fill up the places of such as shall be purged out with such of the well affected officers and Souldiers as have fled out of *Ireland*.
- And the saids Estates gives warrand to the persons before named to convene in such places and at such times as they shall think fit, With power to them to choose Clerks and other members of meeting, And ordaines them at the first meeting to give their oaths of faithfull discharging the said Commission in all the heads and articles thereof, And to report their diligence in the said matter on this side of *Tay* betwixt and the first of *August*, and on the other side of *Tay* betwixt and the 15. day of the said moneth under the paine of ane thousand merks to be payed by the foresaids persons failing to do their diligence, And to report again st the said day.

ACT XII.

Act of the Establishment of the Army, and of the suspended maintenance in the Shires and Burghs.

28 June 1649.



THE Estates of Parliament Considering how just & necessary it is for the ease of the subjects, And to eschew many inconveniences of free quarterings and other disorders, That the forces of this Kingdom, Horse and Foot have an Establishment and Constant pay for their entertainment according to their numbers; They have therefore appoynted the number of the Forces, And the establishment of their pay, To the Officers and souldiers Horse and foot as followes.

ACT XIII.

Act in favours of the Town of Edinburgh.

28. June 1649.

THE Estates of Parliament, now presently Conveened in this third Selsion of this second Triennall Parliament, Taking to their consideration a Supplication given in by the Burgh of Edinburgh, Shewing, That the Committee of Estates finding it necessary for the safety, Peace and good of this Kingdom, That the Town and Harbour of Leith be well fortified and secured, Did Appoint the Magistrates of this Burgh, To go about the Fortifying and securing thereof with all diligence, Authorising them with ull power to do every thing necessary for that effect: And for defraying the great expenfe which necessarily will be laid out and bestowed thereupon, Did assigne and dispone the Excise of all commodities Exciseable (except Wine, Liquors, Ale and Beer) within the said Burgh and Liberties thereof, towards the reparation and fortification of the saids places and providing necessaries thereunto. And that ay and while they should be repayed of their charges and expenses in that work, As the Act of the date of the third of April 1649. at length bears: And likeways the said Committee did Authorize their Magistrates for casting of faill and dovats in any part within a mile and a half to the said place, as their Act of the date the sixt of April bears. And seeing they have entred upon the said work, which is so necessary for the good and security of this Kingdom: Humbly therefore craving, that the saids Estates of Parliament would be pleased to ratifie and confirm the saids Acts: And further for the better enabling the said Supplicants to advance so great a work, that the saids Estates would Authorize this Burgh, To take any Work-Horses, that bring Ale, Coals, or such commodities from the Country to this Town, Leith or the Cannogate with their Sleds, Creills, Hochimes, and such like, and the men that attend them; And to make use of them for the said work, paying for every horse so furnished twenty shillings a day: And they humbly desire these particulars, and what else the saids Estates shall finde expedient for promoting so necessary a work, As the said Supplication bears, Whilk being taken into consideration by the saids Estates of Parliament, They have Approven and Ratified, and do hereby Approve and Ratifie the foresaid two Acts of the Committee of Estates of the dates abovewritten, in favours of the said Burgh of Edinburgh, in the whole heads, Articles and Clauses thereof, And give and grant full power and

and warrant to the Magistrates of Edinburgh or Baylies of Leith, To apprehend, seize, and take any horse within their own Priviledges for serving at the saids Works and Fortifications of Leith at the rate of 24. shillings per diem: And Declare that whensoever any Garrisons shall be put therein, the same shall be entertained upon the publick charges of the Kingdom: And the Estates give hereby power to the Provest, Bailies and Counsell of Edinburgh, To name and place a Governour for the said Town of Leith, Fortifications and Garrisons thereof, who shall have as full power and priviledges, as any other Governours of Forts or Garrisons have within this Kingdom.

ACT XIII.

Act anent Justices of Peace.

29. June 1649.

THE Estates of Parliament considering how necessary it is for the Peace and good of the Kingdom, To have Justices of Peace again established in the severall Shires and Iurisdicions of this Realm of Scotland: Therefore they have renewed and ratified and by these presents renewes & ratifies the Act of Parliament made anent Justices of Peace & their Constables in Anno 1617. And conform thereunto, Have nominate and appointed, and nominates and appoints

To be Justices of peace within And gives and grants full power to them to discharge that office and ministrare Justice thereintill, Impose and exact Fynes from Delinquents, and do every other thing according to the power mentioned in the Act of Parliament 1617. yeers: And to the ends therein specified: And in respect that by the foresaid Act of Parliament 1617. the Justices of Peace are appointed to make compt to the Exchequer of the foresaid Fynes: And the Exchequer for their pains an expenses, And for the other charges whilk will necessarily be given out in the discharge of their Commissions, which hath been a mean and occasion in time past to make the foresaid Act ineffectuall and useles: Therefore the saids Estates of Parliament have repealed and rescinded, and repeales and rescinds that part of the Act in Anno 1617. anent the making Compt to the Exchequer of the foresaid Fynes, With the power granted by the said Act to the Exchequer for modifying of the saids Fees and expenses to the said Constables; And the saids Estates of Parliament grants power to the saids Justices of Peace to allow such necessary charges and expences out of the saids Fynes as they shall finde expedient for advancement of the service

vice: And Ordains them to be comprable to the Parliament or Committee of Estates for the same, And becaule there are sundry Articles in the foresaid Act 1617, That necessarily requires to be rectified which now cannot be conveniently done by the Parliament, Therefore they have Recommended and Recommends Seriously to the Committee of Estates to rectifie the said Articles as they shall find the same just and necessary for the good and peace of the Kingdom, And in the mean time while the same be Ratified, They have Ordained and Ordains the foresaid Justice of Peace to Act and proceed in the Discharge of their Office according to the foresaid Act as it stands in Anno 1617. And thereafter to Act and doe accordingly as the Act shall be rectified.

ACT XV.

Act Concerning the deputation of Clerks to Commissions and Committees of Parliament and touching the keepers of the Registers of Session.

29. June 1649.

THE Estates of Parliament Considering that by inadvertance to the right and interest of the Clerk Register, some Commissions have been granted in this present Parliament, bearing Particular power to the persons thereinmentioned of choosing their own Clerks, whereby the priviledge & right of the Clerk Register may be prejudged, It properlie belonging to that Office to appoynt and depute Clerks to all Commissions and Committees of Parliament as is declared by former Acts of Parliament, namelie the 24. Act of Parliament, 1641. And the present Clerk Register having speciall right thereto by the gift granted to him of the said Office, and he and his Predecessors having been in possession accordingly, Therefore it being no wile intended to prejudice the Clerk Register, nor the priveledges, dues and interests of that place in any sort, The said Estates do Appoint and Ordain, that all persons who are or shall be admitted Clerks to any Commissions or Committees of Parliament by vertue of any power contained in their Commissions, or by any other power or right whatsoever, not having right or deputation from the present Clerk Register or his Predecessors, shall come to the Clerk Register within twenty dayes after the publication of this Act, And procure and obtain deputation and right from him; Otherways the said Clerk Register shall appoint and depute other Clerks to the said Commissions and Committees, who shall be received and admitted by them to serve as their Clerks, And all other persons shall be discharged from that service, their admision

admission by vertue of the power granted in the said Commission, or by any other Right without deputation of the Clerk Registers for the time notwithstanding: And for preserving the right and interest of the Clerk Register, The said Estates do hereby discharge or inhibit any clauses for giving power to any Commissioners or Committees of whatsoever nature to choose their own Clerks to be insert in any Commissions to be appointed hereafter by the Parliament, without the speciall consent of the Clerk Register: And if any such clauses shall be foisted in, the same shall be null and void: And the said Committees and Commissioners are not to Act by vertue of the same, but the Clerk Register and his successors shall appoint and depute Clerks notwithstanding thereof: And the Estates of Parliament do recommend unto, and Ordain the Clerk Register for the time, to take speciall care to appoint and depute all well qualified and honest men in the said Offices, and in any other charges and services under him: And likeways that he call them to an Account of the discharge of their Offices, and particularly that the Leiges may not suffer by the negligence or other faults of the keepers of the Seafings, reversions, or other Writs appointed to be Registred by the Act of Parliament 1617. He is to take speciall tryall if the Duties injoynd to them by the said Act of Parliament be lawfullie performed and observed, And to inflict the censure therein mentioned against the Transgressors, Appointing also Letters to be direct upon this Act, at the instance of the present Clerk Register and his Successors, if need be.

ACT XVI.

Act for punishing the horrible crime of Incest with death.

9. July 1649.

THE Estates of Parliament considering that it is already Ordained by the 14. Act of the first Parliament of K. F. 6. That whatsoever person or persons, who are guilty of the abominable & vile crime of Incest in any of these degrees which Gods word hath expressly forbidden in the 18. chapter of Leviticus, shall be punished to the death: And considering also that there be many other degrees of incest both in affinity and consanguinity, no less hainous and punishable then these expressed in the Letter of that Text, because they be either neerer or fully as neer: Therefore the Estates of Parliament, being desirous to provide a sufficient remedy against all these evils, And that the wrath of God (which could not but lie heavy upon the Land, by impunity of such abominable crimes) may be averted, Do ratifie and approve the said Act; And further Declare and Ordain, That not only those persons who are guilty of any degree of Incest, exprest in the foresaid Text: But also that whatsoever person or persons shall hereafter be found guilty of any other degree of Incest either neerer or fully as neer in affinity or consanguinity, as these that are expressed in the Letter of the foresaid Text, shall be punished to the death, And that such persons may be the better known, The saids Estates findes and declares all these degrees mentioned and set down in the following Table to be Incest and punishable by death. ACT XVI.

Act for Redress of the Complaints and grievances of the People, against Masters, Collectors, Officers and Souldiers. 5. July, 1649.



THE Estates of Parliament taking in to their serious consideration the manifold grievances and complaints within the Kingdom against Masters, for oppressing their Tenants in outreiks of horse and foot, payment of the monethly Maintenance, and in Quarterings, as also against Officers and Souldiers, and Collectors of moneys for their disorderly carriage and unjust dealing. For remedy and redresse herein, they do Statute and Ordain,

1 That the severall Presbyteries send in to the Committee of Estates, a list of nine or ten understanding and conscientious men, that upon consideration thereof, and such other Information as shall be given to the Committee of Estates concerning these or any other persons, they may make choyce of five or six; to employ in that trust, and any three of them to have power to do and put in execution all things within the bounds of each Presbiterie, which are referred to them by this Parliament, and that all grivances and complaints for wrongs done since the first of October last, or which shall be committed in tyme comming, being such as are by this Act referred to them by the Parliament, shall be presented to the said persons so nominated and chosen, and that the person first nominated in the Commission, shall convene the rest at their first meeting, and take their oaths for the faithfull discharge of their duty, and then the next in Commission shall take his Oath, and that thereafter they meet at such times and places as they shall thinke fit, That they shall have power to convene all persons interessed within the bounds of the Presbiterie before them, to take the Oaths of parties, and to examine witness upon Oath, when when they shall see it needfull, and that all Officers and Souldiers shall be assitant to them upon their direction for executing the power committed to them.

2 That in all Levies of horse, the Tenant shall only furnish a sufficient man, and shall be free of all charge and expence whatsoever, unlesse they be rentallers or others, who have lands set unto them under the known worth and value, in which case, the Commissioners of each Presbiterie to be chosen as aforesaid, shall have power to determine what shall be the proportion of the renter or others aforesaid, according to the ease they have of the land under the known value, Consideration being had what the tenant gave to the master at his entrie to the lands, together with the yearly dutie and service; And that no rentaller, nor other aforesaid, shall be lyable to the payment of any part of the said levy, but upon decreet of the Commissioners aforesaid, & that the heretors in the interim put forth the Levie, It being alwayes understood, that where rentallers are already valued, distinct from the heritors by the Commissioners appointed for the valuation of the shire that they shall pay conform to their valuation.

3 That in the Levies of foot the master shall find armes, and pay the advance or loan money, and that the tenant shall onlie find a sufficient man, and shall give unto him that shall goe forth the sum appointed by Act of Parliament to be given by tenants, unlesse they be rentallers or others before mentioned, in which case, the said Commissioners shall determine as aforesaid what shall be their proportion.

4 That no master shall for benefit, spleen or private revenge, put forth any tenant or servant in Levies, but that where there is any such complaint the Commissioners aforesaid shall iudge of the fitness of the person.

5 That the Monethlie maintenance shall onlie be payed by the master, and the tenant

tenant to be free, unless they be rentallers or others as aforesaid, in which case, the Commissioners are to determine their proportions as is before expressed.

6 That all quarterings, whether local or transeunt shall be allowed in payment of the Monthly maintenance in manner following, *viz.* that the master, or such as have power from the master to doe his affairs, shall deliver to the Collector a certificate, subscribed by two of the Commissioners aforesaid, that he hath allowed to his tenants the said quarterings (which are also to be instructed according to the act of Parliament) in their maill or yearly rent and duty, and given them discharge for the same, before he get allowance of the quarterings in payment of the monethly maintenance, & that the Collector deliver in the said certificate to the General Commissary, Or in case the master refuse to give the said certificate to the Collector, that then the collector bring two of the Commissioners certificate of the master his refusal, and if the Collector shall fail herein, that then he make accompt to the General Commissarie, for the whole monthlie maintenance, without any deduction for quarterings, and that the Commissioners take care that the masters so refusing doe allow the said quarterings to the tenant in their maill and duties.

7 And because quarterings upon particular persons, may exceed their proportion of the monethly maintenance, It is therefore statute and ordained, that the Collector of every shire shall make payment to all such persons as shall be so overburdened with quarterings out of the monethly maintenance of the shire, at the direction of the committee of war, And if the whole monethlie maintenance of any shire shall be exhausted that then the General Commissarie shall make payment to them for the said quarterings out of the monethly maintenance of other shires whose maintenance is not exhausted by quarterings. And in case any master shall thrall his tenants, and forcethem to lay out any monies in levies otherwise then according to the directions of the Parliament, or being desired, shall not allow them the maintenance when they have been necessitated to pay the same for their masters, or quarterings, not exceeding the Maintenance, The Estates of Parliament do Decleare, that upon probation thereof before the said Commissioners (the master for so doing shall beside restitution to the tenant) pay as much to the Commissioners for the use of the publick.

8 That where tenants have not concurred in *James Grahams* rebellion, or been accessorie to the late unlawfull Engagement against *England*, or the late Rebellion in the north, but have suffered therein, effectuall course be taken for their ease and relief, that it be not in their masters power to oppresse and destroy them, And that the losses of all such tenants as have suffered for their affection (there masters being guilty of any of the crimes aforesaid) be cognosed and tryed before the said Commissioners, and what allowance and deduction shall be decerned by them, to be retained from their aforesaid masters (guilty as said is) shall be a sufficient exoneration and discharge to them of the maills and duties *pro tanto*, and is to be so allowed by all and whatsoever Judges before whom the said duties are to be persued. And that the master be not permitted to pursue them for these duties before their own Courts, and if the master shall do otherwise, the tenant to have repetition *pro tanto*, provided, that nothing herein contained shall extend to infringe any capitulation approved by Parliament.

9 That all Collectors of monies within shires have testificats of their honestie and fidelitie from the Presbyterie, and subcollectors from the sessions where they live.

10 That no Collectors shall quarter souldiers upon any for deficiency in payment of publick dues, unless there be intimation given six dayes before to the President, or in his absence, to any two of the Committee of war of the shire & to the partie deficient; And that no officer shall quarter souldiers upon any for their deficiency in payment

of

of publick dues, unless they have a warrant for the same, under the Collectors hand, or have order from the Committee of Estates or general Commissarie: And if any collector or officer doe otherwise, that he shall be cashiered and removed.

11 That if any Collector shall exact more from any master or tenant, then the just proportion, or shall cause them make twice payment of the same sum, that he shall pay the double thereof to the persons whom he hath so wrongd, and not only be removed from his office, but shall be declared incapable of any trust hereafter, likeas if any Collector shall refuse to allow quarterings from the first of this moneth, being rightlie instructed, and within the monthlie maintenance, he shall be punished in the same manner, and this is without prejudice of the Act of Parliament for relief of preceding quarterings.

12 That if any officer or souldier shall exact money by paction or otherwayes from any master or tenant to Burgh or land beside their pay, *viz.* in time coming twelve pence for the trooper, and six pence for the foot souldier, or shall plunder any goods, that he shall repay the double unto them, forfeit all his arrears to the publick, be cashiered with disgrace, and declared incapable of any trust hereafter, and shall be further punished according to the Articles of war.

13 That in case any officer or souldier, shall force master or tenant to Burgh or land, to give him a discharge when he hath payed no money, or lets then his quarterings extend to, or shall offer any violence against master or tenant, by beating them or otherwayes, the same Punishment shall be inflicted on him.

14 That if any officer or souldier shall in the place of the country where they quarter, willfully thrust his horse into cornes, or meddews which use to be mown yearlie, or where there is young planting, that they shall forfeit a moneths means: And if any officer or souldier shall at his own hand presume to take any mans horse for riding, or any other use, the officer or souldier so doing, shall pay the price of the horse to the owner, and also forfeit a moneths means.

15 That if any troop, or Company, or part thereof shall quarter in any place, and at their removal, shall neither pay compleatlie for their quarters, nor leave a ticket (which they are to doe without demanding any money for the same) or shall leave a ticket for a shorter time then they did quarter, that there shall be detained of the officers pay, who had the charge of that troop or company upon the place, the double of what shall be found due for the quarter, and in case the officers pay be not sufficient to defray what shall be so restand, that the remainder thereof shall be defalked out of the souldiers pay, and given to the party on whom they did quarter.

16 That no troop nor Company shall in their transient quarters stay above one night in a place, and that the horse shall march at least fifteen miles, and the foot ten miles, except upon the Lords day or otherwayes, that the double of every nights quarter shall be allowed out of their pay to these upon whom they quarter, unless there shall be an evident necessitie or order from a General Officer.

17 That to prevent the abuse of officers and souldiers in demanding extraordinary fare, their pay be delivered to them, at the end of every fourteen dayes (or sooner if they remove) by the shire, or collector of the shire where they are quartered, and that they shall pay ready mony for whatsoever they take for themselves, their horse, and the servants of Commanders, at the ordinarie rates of these places where they are quartered, without extortion, and if any officer or souldier, receiving their pay as aforesaid shall do otherwayes, that they shall forfeit a moneths means for the first fault, and if after complaint made, they shall continue so to do, that they shall be cashiered.

18 That all persons who have furnished quarter to any troop, or Company, or part thereof,

thereof,

whereof, without payment either upon or without biller, that they instruct the same before the Committees of the respective shires where they dwell, by the said billets, and where the souldier hath not left billets, to instruct the same, according to the acts of Parliament for allowing of quarters by two of the Committee of war, each moneths quartering before the tenth of the subsequent moneth, to the end, that each Company, troop or regiment may be truly charged with what they have received, & so much of their pay discomted to them, and accordingly allowed in the monthly maintenance.

19 That no quarter be allowed to women or pedies attending upon troops or companies, and that all officers be carefull to see this dulle observed, and in case they shall fail herein, that they shall forfeit a monethes meanes.

20 That the Commissioners aforesaid have power to heare & determine all questions & differences that have arisen betwixt masters and tenants since the first of October, or shall arise in tyme comming concerning the out-reikes of horse and foot, the payment of the maintenance, and touching quarterings according to the directions of the Parliament before expressed.

21 That the said Commissioners doe likewise certifie to the Committee of Estates the names of all such masters as have oppressed their tenants in any time by-past in the out-reiks of horse and foot, payment of the maintenance, or in quarterings, or have any wayes made benefit to themselves therein contrary to former Acts of Parliament, or who shall hereafter wrong their tenants contrary to the present directions of Parliament, and shall send therewith the proofs of the said wrongs so committed, to the end the said persons may be fined and censured as the Committee of Estates shall find their faults to deserve.

22 That when any complaint shall be made to the Commissioners aforesaid against collectors for their transgressing the orders and directions of the Parliament, that the Commissioners shall call the parties before them, and after exact tryall, represent the whole matter to the Committee of Estates, and send the depositions and proofs therewith, that the Committee may take speedie course for redress of all just grievances.

23 That when any complaint shall be made to them against any officer or souldier for transgressing the orders and directions of the Parliament, if after tryall of the matter, it shall appeare to them to be a just grievance, that then they represent the same to the chiefe officer that is upon the place, and desire reparation, and if there be no officer on the place above him against whom the complaint is made, that then they desire himself to make reparation, and if in any of the cases aforesaid reparation and satisfaction shall not be speedily given, that then the Commissioners certifie the whole matter to the Committee of Estates, and send the depositions and proofs of the particular crimes and faults, that the parties wronged may be repaired, and the parties offending may receive condigne punishment, and that the officer denying or delaying to repaire the wrong, shall for the first fault forfeit a moneths meanes, and shall be cashiered for the second.

24. That these presents be Printed, and sent to the respective Presbyteries within the Kingdom speedily, that they may send in a list of persons to the Committee of Estates as is before expressed, and that these presents be likewise read in all Parish Churches.

ACT

ACT XVII.

Act for proportionating the Levies of Horse according to the Maintenance.

12 July 1649.

THE Estates of Parliament Considering how just and necessary it is for the good of the Kingdom, That all the Levies and outreike of horse be proportionate upon the heretors and others lyable for the said Levies in an equall way in all time comming; Therefore the said Estates have ordained and Ordain That the Levies and outreikes of horse in the severall shires within this Kingdom of Scotland shall be proportionate in all tyme Comming upon the shires, and upon the heritors and others lyable in the said Levies and outreikes within the said shires respective in an equall way according to the Maintenance payable by the said shires, heretors and others as said is.

ACT XVIII.

Commission for the Committee of Estates To sit at Perth.

18 July 1649.

THE Estates of Parliament Taking to consideration that the Peace of this Kingdom hath been much disquieted and disturbed this time by-past, Through the many Murders, Thifts, Wrongs, Burnings, and Depredations, Rebellions and Insolences which have been done and committed By the Highlanders and Ins-men and others disaffected persons in the Kingdom, As likewise considering the laudable course formerly set down and prescribed in diverse Acts of Parliament made anent the quieting of disordered subjects in the Highlands and elsewhere, As also that the said Estates of Parliament by their Act of the last Session thereof, Ordained precepts to be issued forth for citing such persons as were upon the late Engagement against England, or others as they should think expedient, to compeer before them or their Committee to give surety and subscribe the band and declaration for keeping and on no wayes disturbing the present peace and quiet of the Kingdom, Therefore the said Estates of Parliament to preveen any danger or disturbance which may arise to



To the Kingdom, and to secure the subjects from the stouth, violence, wrongs and oppreffions of all rebellious lawles and Malignant persons, Doth hereby give full power, warrand and Commission to the Committee of Estates or their Quorum To meet at Perth upon the Twentie fourth day of August next, with continuation of dayes, And to call before them, all such persons within the Isles, Highlands, and all other places as were upon the late Engagement against England, or have been Accessorie in any manner of way to the troubles of this Kingdom, And siclyke all Land-lords and Bailies of Lands where broken men do haunt or dwel, and chieftons of clans and forners oppreffours and others who by thefts, slaughters or depredations have troubled the Countrie, To subscribe the band and Declaration, and finde surety for keeping the present peace of the Kingdom, And to give satisfaction according to the former Lawes of the Realm, And to underly and obtemper any orders the Committee shall appoynt them for that Effect; With power to them to doe all other things Necessary for keeping the peace and quiet of the Kingdom.

ACT XIX.

Act anent the Localitie of the Forces Horse and Foot within this Kingdom.

Viz. July 1649.

THE Estates of Parliament taking in to Consideration the best and fittest wayes forpaying of the army, and disposing of them into such places as they may be best accommodated, Therefore Do assign unto them the severall Shires and Burghs for their localities and quarterings in manner and according to the proportion of maintenance as after follows, viz.

I The garison of Stranever consisting of 100 men and Compleat officers of a company, Their monethly pay according to the establishment, extends to a thousand one hundred fourteen pound, thirteen shillings four pennies, To be payed as follows, forth of the maintenance of the Shire of Caithnes 724. l. 17. s. 11. d. The maintenance of Sutherland. 439. l. 4. s. 9. d. the burgh of Dornock 27. l. which payes the Garison And 77. l. 2. s. 4. d. remains to be payed by the Earle of Sutherland.

## ACT XX.

*Act anent the Removall of the Forces of this Kingdom to their Localities, and Anent transient Quarters.*

3. August, 1649.

**T**HE Estates of Parliament finding it necessary that the Regiments, Companies and Troops within this Kingdom, be appointed to go with expedition to the severall Places where their localities doe lie, and likewise that the pay of the transient quarters of the severall Regiments, Companies and Troops be cleared: Therefore they have Ordained, and ordaines, that the severall Commanders of the Regiments, Troops and Companies shall receive under the hand of the Generall Commissary or his Deputes, the severall Places Ordained by Act of Parliament for their localities, with the particular sums of their Pay; And that the General Commissary give orders to the severall Collectors to go with the Officers of the respective Regiments, Troopes and Companies to the Committees of War, whereby the Committees of War may regulate their severall divisions according to the localities of the Maintenance of Shires and Burghs therein, whereby Marches may be cleared, and they accommodated, every one according to their own locality; with the least prejudice to the Shire, and satisfaction to the Forces, so as all may be kept clear betwixt Collectors and the Forces.

And in regard there will be a necessity of Regiments, Troops and Companies marching from place to place to their localities, or upon other emergents, and so must of force march thorow others localities; The Estates of Parliament Ordains, That each Regiment, Troop or Company so Marching, shall be obliged to leave Billets according to their just number for their quarterings, subscribed by the officer who commands the Regiment, Troope or Company for the time, and the Commander to take the Testificats of the Collector, or Commissioner of the Paroch for the time, or the Testificat of some honest Gentlemen within the said Paroch where he quartered, that he has left with them one just Billet of the whole number of all these quartered by him or any under his command, and that under the pain of cashiering him, beside other punishment, and that the Billet so left by the officer be allowed to the severall Heritors by the Collectors of the Shire in the first end of their maintenance, and that each Footman be allowed at five shillings *per diem*, and each Trooper at ten shillings *per diem*, and that each Regiment, Troop or Company who hath their locality within that Shire where the Billet is left, shall accept the Billet off the Collectors of the Shires hand for payment *pro tanto*, and

and that the Collectors in the severall Shires, who has the Collecting of the maintenance where the localities of the Regiment, Troop or Company who left the Billet lieth, shall be obliged to pay and refund back to the Regiment, Troop or Company who has accepted the Billets for payment out of the first end of what is due to the Troops, Regiments or Companies that left the Billets, and where Billets are not left, that the quarterings shall be allowed to the Heritors in the first end of their maintenance off the localities of these that quartered upon them, & the quarterings to be proven *in Communi forma*, and when necessity shall occasion the calling together of any number of the Forces, that they be still obliged to give Billets of their quarter, and if any Shire shall be overburthened above their maintenance, that they shall have repayment off the Collectors of other Shires where these Troops, Regiments or Companies who gave the Billets has their localities, And the Collectors are hereby ordained not to pay mony to any Troop or Regiment after their removing from their locality, But to Collect and keep the same in their hands for Payment of the transient quarterings, and satisfying the Forces of what they have not taken up by quarters.

## ACT XXI.

*Act and Commission for a new Valuation.*

4. August 1649.

**T**HE Estates of Parliament taking unto their consideration the many complaints and grievances within the Kingdom, against the unequality that hath been in bearing publick burdens, and being desirous that all the shires of the Kingdom, and every person within the same, may bear an equall proportion, according to the true worth of their Estates. Therefore they do nominate and appoint for the Sherrifdom of  
or either of them conveners for the first meeting, and

which Commissioners for the said Shire shall meet on *Thursday* the 30. of *August* next, or sooner, as the Conveners shall appoint, and choose a Clerk and other members of Court necessary, and the Estates of Parliament do Ordaind the said Conveners, or either of them to take the solemn oaths of the saids Commissioners, that they shall use their best endeavours for a right and true information of the whole rents of the said Shire, and that they shall proceed faithfully and impartially in prosecuting their Commission, and the Instructions relating thereunto: With power to the said Commissioners, or the ma-

for

for part of them as a *Quorum*, and if the major part exceed five, five to be a *Quorum*, to rectifie and improve to the best avail the former Valuations; And for that effect, to direct our summons against such Person or persons within the Shire, as they shall think fit to compeir before them, and to declare upon Oath the true Rents of any Paroch or place of the Shire, according to their knowledge, and in case any shall contemn or refuse to compeir and depone, to imprison or fyne them into a pecuniall summe, not exceeding one hundred pounds, and to take all such further Information, as they shall finde necessary for getting knowledge of the true worth of the whole Rents within the said Shire, as well casuall Rent of all sort, as constant Rent in stock and reinds, and the true value and worth of every land and rent set in tak or Rentall, and what the true yeerly worth thereof is, by and attour the rentall, or tak-duty thereof payable to the Master, (respect being had to the gressum or entresse, if any was payed by the Takemen or Rentaller at his entry; And of all Few, or Tak-duties payable to any person, his Majesties duties excepted) and of all other casualties payable for stock, or teynd according to the table annexed. All which they are to value exactly, by converting the victuall into money, according to the respective prices set down in the said Table, and by converting casualties into money, at the just rates which they give for the time in that Shire where the said casualties and commodities are valued. With power likewise to the said Commissioners, or the major part of them as the *Quorum*, and if the major part exceed five, five to be the *Quorum*, to take all former valuations into consideration, and rectifie the same where they have been unjustly valued, and where they finde that any person hath been undervalued, to augment the valuation of their rent to the true worth, and adde the same to the totall of the rent of the Shire, and thereby bring the whole rent of the Shire to the full value, and also reduce the whole Shire to an equality and proportion among themselves. And in the forming their report, the said Commissioners shall set down a Roll for every Paroch, which in the first place shall contain the mony Rent of the Paroch, Secondly, the quantity of the victuall payed in the Paroch, and the severall species thereof; and what measure, and how much the same doth amount unto, being converted into money. Thirdly, the kinde of casualties or customs payed for stock, or teynd, the number thereof, and the price of each casualty distinctly, and how much the same doth extend to in whole, being converted into money. Fourthly, the casuall Rent according to the Table, and what it doth extend to. Fifthly, the Few and Tak-duties (his Majesties excepted) and what the same doth extend to. Sixthly, the mortified rent, and how payed in money, victuall, or casualty, and what the same doth amount to. Seventhly, the duties payed to his Majesties Exchequer, and the sum thereof; And after the Roll of all the Paroches are set down, then they are to cast up the totall of the valuation of the whole Shire, by and attour the mortified rent and duties payed to the Exchequer, which are to be summed in an Article apart, and

and in a third Article they are to set down the totall of their former valuation, which is herewith delivered to the Commissioners for ilk Shire, under the Clerk Registers hand, and lastly they are to set down what this present valuation to be made, doth exceed the former valuation; In all which, the form and pattern subjoynd, is to be observed. And the said Commissioners are to subscribe the Report formed as aforesaid, and to deliver the same to the Clerk Register or his Deputes; betwixt and the first of *November* next to come, and in case any Shire shall fail therein, or shall bring in a Report not agreeable to the Rules and Directions now prescribed, they shall pay the half more of Maintenance than they are appointed to pay by the present Act of Maintenance, ay and while they produce and report their valuations in manner before prescribed, and if the failzie shall be on the part of the valuers, or any of them; the rest of the Shire shall have their relief off them. And further, the Commissioners are to send one from each Shire with the said Valuation against the first of *November*, which Commissioners shall meet with the Committee of Estates for comparing the said valuations, and perfecting the same, that they may be a Rule for the future in imposing all publik burdens according to an equall proportion, and if there be any difference which cannot be settled by the Committee of Estates, and the said Commissioners, that it be referred to the Parliament. And it is hereby declared, that no respect shall be had to any valuation to be reported, that shall be under the totall of the former valuation, which is herewith delivered to the Commissioners of ilk Shire by the Clerk Register, *Extractum. The totall of the former valuation of this Shire is,*

ACT XXII.

Act anent the Age of Noblemen to sit in Parliament.

6. August, 1649.

THE Estates of Parliament considering how necessary it is That all persons Having power of publick trust in those great Judicatories of Parliament and Privie Counsel, should be of ripe age & experience, sufficiently qualified for the exercise of these places, and discharge of that trust to the good of the Kingdom, And that such abilities and experience fit for a publick charge, cannot well be attained to by those who have not attained to the Age of twenty one years, who are not allowed through non-age to order and govern their own private affairs: It is therefore Statute and Ordained, That no person of whatomever quality or degree shall be admitted To sit and voice in Parliament or Privie Counsel, unless he be of the age of twenty one years at least.

ACT XXIII.

Act of Levie of Horse and Foot within this Kingdom.

6. August 1649.

THE Estates of Parliament considering how necessary it is for the good of the Kingdom, That the remanent of the Horse and Foot that were appointed to be raised and put forth by the Act of Levie of the date the twenty eighth day of February last, and are not as yet put forth, should be in readinesse upon advertisement; Therefore the saids Estates of Parliament Have Ordained, and do Ordain the whole Shires and Burghs within this Kingdom presently to raise and have in readinesse the rest of the Foot mentioned in the said Act, and not as yet raised and put forth, viz. with all publick dues to be uplifted by them, and how the sames are given out and employed without prejudice of their making compr and payment to the Generall Collector of the maintenance due by the shires, the Burghs being alwayes free of the saids fees, And the saids Estates ordains that the letters and charges to follow upon this Act for payment of the said moneth of July last bypast, Shall be raised and directed at the instance of the said Sir James Stuart against the sub-collectors of Shires, Magistrates of Burghs, and at the instance of the collectors of Shires and Magistrates of Burghs respective against the Sub-collectors of Paroches, heretors, sewers, life-renters and others indepted in payment of their severall proportions of the saids moneths maintenance now imposed, And with power to the said Sir James Stewart that if any Shire or Burgh be deficient in payment of their partes of the said moneth of July, to employ any forces that shal happen to be upon the bounds for the time, or in the next neighboring bounds adjacent thereto for uplifting of the maintenance of the said moneth of July last bypast from the deficient shires, Burghs and paroches, which troops are to receive their entertainment from the deficient at the ordinary rates beside the payment of their maintenance, And the saids Troops or parties shall not be employed to quarter upon the deficientes till first there be Six dayes warning given to the deficientes, or at the parish Kirks where there lands lyable for the said maintenance lies, And it is hereby Ordained that the Committees of war in the severall Shires shall be aiding and assisting to the said Generall Collector herein for inbringing of the saids moneths maintenance, and in regard of the prorogating of the foresaid maintenance on the shires and Burghs for the said moneth of July, It is statute and Ordained by the Estates of Parliament that every debtor shall have retention from the Creditor of one & an halfe of each hundred for one years annuall rent proportionally for the said moneth of July last bypast, So that the debtor shall be lyable in payment of six merks 6 s. 8 d. of annuall rent of each hundred merks of Stock proportionably according to the said moneth, And in regard of the present distressed condition of the Sheriffdoms of Argyle and Bute, The Estates do exeem the whole Sheriffdom of Argyle, from payment of the said moneths maintenance of July last bypast, Except the lands of Morven, Ardour, Kingierloch, and the Iles of Mule, Terie, Cole, Icolunkelne, Muk, and Rowm, The maintenance whereof is assigned to Hector Macklean of Torloske for keeping the strength and Garison of Barneboil, As also exeemes the Sheriffdom of Bute from all payment of the equall halfe of the said moneths maintenance, And ordaines the said shire of Bute to be onely liable in payment of the other half of the said moneths maintenance, and to be proportionable payed by the heretors and others lyable in payment thereof through the said whole shire of Bute, as also the Estates declares this present Act to be but prejudice of the Act granted in favors of the town of Innerneffe of the first of January 1647. THE Estates of Parliament now presently convened in this third Session of this second triennall Parliament: Being upon good reason to dissolve for this present Session of Parliament, and to continue the same to an new dyer, and considering how necessary it is (for the good of Religion, King and Kingdomes, for preventing and remedying of all evils and dangers that may befall to any of those from intestine Comitions or forraign invasions, for preserving the peace of the Kingdome, and Union betwixt both: And for doing, acting and ordering all things relating either to peace or warre agreeable to the Covenant and ends thereof,) that a grand Committee be nominated and appointed by them of able and well qualified persons; Do therefore nominate, elect and make choise of the persons following, viz. THE Estates of Parliament having taken the report given in concerning Master Lampsones businesse to consideration, and in particular that part thereof appointing the annualls to be reduced to six for the hundred constantly in all time coming, Do therefore Ordain the annualls of the money to be reduced, and by these presents reduces the same to six for the hundred in time coming without alteration, from the first of this instant; And declares the said six for the hundred to be free in all time coming of all Retention and publick burdens: And the saids Estates appoints thirteen thousand pound Stirling as a part of the sums due to Master Lampsones to be laid upon the Maintenance of the whole Kingdom Burgh and Land, according to the rule of Maintenance, by adding to the Maintenance eleven hundred pound Stirling monethly for twelve moneths after the first of this instant August without any deduction for Quarterings, or any other cause whatsoever, and refers to the Committee of Estates to proportion the foresaid sum to be payed by the Shires and Burghs monethly, according to the Maintenance.

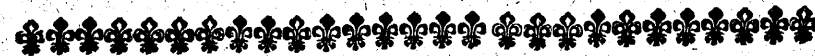
