REPORT.

THE COMMITTEE to whom the Report was Re-committed, which was made from the Committee, who were appointed to confider of the Persons to be appointed Commissioners, Surveyors, and Valuers, in BILLS of INCLOSURE and DRAINAGE; and to report the same, with their Opinion thereupon, to the House:—

AVE, pursuant to the Order of the House, further confidered the Matter to them referred; and have come to the following Resolutions:

Resolved

THAT it is the Opinion of this Committee, That, after the present Session of Parliament, in every Bill for inclosing any Moors, Commons, Waste Lands, Half Year Lands, or Uninclosed Lands, and in every Bill for draining any Low Lands, there be inserted a Clause or Clauses to prevent any Lord, or the Steward,

Bailiff,

Bailiff, or Agent, or any Person who hath been Steward, Bailiff, or Agent, within the Space of Three Years previous to the Royal Affent being given to such Act, of any Lord or Lady, of any Manor or Manors extending over the Whole or over any Part of the faid Moors, Commons, or Waste Lands, Half Year Lands, or Uninclosed Lands, intended to be by such Bill inclosed, or Low Lands intended to be by fuch Bill drained; and also to prevent any Proprietor or Person, immediately interested, or the Steward, Bailiff, or Agent, or any Person who hath been Steward, Bailiff, or Agent, within the Space of Three Years previous to the Royal Affent being given to fuch Act, of any Proprietor or Perfon immediately interested in such Moors, Commons, or Waste Lands, Half-Year Lands, or Uninclosed Lands, intended to be by fuch Bill inclosed, or Low Lands intended to be by fuch Bill drained; from acting as Commissioner, Surveyor, or Valuer, for the inclosing such Moors, Commons, or Waste Lands, Half Year Lands, or Uninclosed Lands, or for the draining such Low Lands.

Resolved,

THAT it is the Opinion of this Committee, That, after the present Session of Parliament, in every Bill for the inclosing any Moors, Commons, or Waste Lands, Half Year Lands, or Uninclosed Lands, or for the draining of any Low Lands, there be inferted an Oath or Oaths, Assirmation or Assirmations, to be taken by every Commissioner, Surveyor, and Valuer, of Lands intended to be by such Bill inclosed or drained, that he is not immediately interested in the Lands so intended to be inclosed or drained, and is
